TERMS AND CONDITIONS OF CONTRACT

A . Africabet is the trading name for a partnership which is headed by Mr B Makwabarara as its principal partner and operates from various branches throughout the country . Our main call centre is at No 26 Fife Avenue Harare .

B . The Customer whose details appear overleaf hereby applies for a telephone betting account .

1 . APPLICATION

The following terms and conditions shall apply to the telephone betting contract entered into between the Customer and Africabet .

- á) The Customer by signing the application form shall be deemed to have read and offered to Africabet to conclude an agreement according to the conditions of use as set out herein .
- â) The residential address which the customer furnishes on the application form will serve as his /her domicilium citandi et executandi for all purposes .
- ã) The customer must be over the age of eighteen (18) years in order to apply for a telephone betting account .
- ä) Africabet reserves the right to request proof of age from the Customer prior to considering the application .
- å) This account may only be used by the Customer and is not transferable .
- æ) The Customer agrees that if Africabet deems it necessary Africabet is entitled to, at their own discretion perform a credit check on the credit worthiness of the customer .
- ç) Africabet reserves the right to confirm the bet and or /reject and or reduce the potential win on any bet .
- è) No interest will be paid on credit accounts .
- é) Africabet reserves the right to close the account at any time and any monies owed to the Customer will be paid out immediately .
- ê) In the event that the Customers account is in debt the amount outstanding as at that time will immediately become due and payable .
- ë) The Customer accepts that it is his /her responsibility to be aware of the General Rules and Regulations relating to horse or sport betting as set out by Africabet and bets cannot be voided .
- ì) Africabet is regulated in the first instance by the Betting and Totalisator Control Act and by the Zimbabwe Bookmakers Association .
- í) By law Africabet is subject to the Gaming Board and as such is bound by their rules and regulations which the Customer accepts he is fully aware of .
- î) Africabet reserves the right to record all calls .
- ï) Africabet will from time to time regulate the maximum payout per ticket . Split bets (same bet different ticket number)will be deemed as one ticket .

2 . PAYMENT

- á) The account will be operated on a deposit only basis. In order for the account to be active ,money needs to be deposited .
- (b) Credit will only be given, authorized and signed for by the principal partner. Any credit not sanctioned by the principal partner will be regarded as unlawful and Africabet reserves the right to place criminal & civil charges against all partners involved.
- ç) A deposit of US \$100 / ZAR1 000 is required when opening a new account .Where a bonus is awarded on a deposit i.e. first deposits for newly opened accounts, the full deposit amount plus the bonus must be used in full before any withdrawals can be made. from the account.. If credit is granted Africabet will determine the limit of such credit in its sole discretion and may vary that limit at any time .
- ð) Africabet will not be obliged to place a bet in the event that there is insufficient credit in the account .
- é) In the event that the customers account is in debit the amount will be payable on or before the following Tuesday regardless of when the bet was struck .
- í) Any amount not paid by the Customer on due date shall bear interest at 50% above the normal bank interest at the time .
- ê) In the event that the customer calls a bet incorrectly Africabet will not be responsible for any damages suffered by the Customer from any cause whatsoever .
- ë) Africabet would not be responsible for any loss of profit or any damages suffered by the Customer from any cause whatsoever either directly or indirectly consequential or otherwise .
- ì) Without derogating from the generality of the foregoing Africabet will not be liable for its own negligence or the negligence of any of their agents or employees .

TERMS AND CONDITIONS OF CONTRACT

3 . SUSPENSION OF CUSTOMERS OBLIGATIONS

If any amount owing by the Customer is not paid on due date then without prejudice to any other right it may have Africabet may immediately suspend the carrying out of its then uncompleted obligation until the payment is made .

4 . JURISDICTION

- a) Africabet will be entitled to institute any proceedings against the Customer arising out of the contract for the full balance outstanding in the Magistrates Court having jurisdiction over the Customer notwithstanding that the claim or the value of the matter in dispute may exceed the jurisdiction of the Magistrates Court . Further the Customer agrees to be liable for legal costs including costs on the attorney client scale and collection charges , including tracing costs which may arise .
- b) A certificate signed by an employee of Africabet showing the amount due and owing by the Customer to Africabet at any given time shall be conclusive proof of the facts therein stated for the purpose of all legal proceedings against the Customer for recovery of the said amount .
- 5 . This contract constitutes the entire contract between the parties and no representation by any person variations or amendments of any of the terms or conditions hereof shall be valid and binding on the Customer unless reduced to writing and signed by both parties .
- 6 . No extension of time or any other relaxation or indulgence granted by Africabet to the Customer shall operate as or be a waiver by Africabet of its rights under this contract or a novation or any of the terms and conditions of this contract .

7 . CONFIRMATION OF BETS

Only bets that have been confirmed by the operator will be deemed as valid bets .

8 . INTERPRETATION

The headings in these conditions are for convenience only and are not to be taken into account for the purpose of interpreting the contract .

AFRICABET RULES AND REGULATIONS

BETTING WITH AFRICABET

All bets struck shall be subject to fixed odds betting (odds determined by Africabet before or after the event). The minimum bet is \$5 or R50. (Please note that our current exchange rate Rand to US is 10 to 1. All payments will be in US Dollars converted at 10 to 1 to the Rand. This is subject to change without notice.)

SCRATCHINGS

WIN, PLACE, SWINGER, TIERCE AND QUARTET

If a horse is scratched; there is a full refund on all bets affected by the scratched horse.

PICK 6, PLACE ACCUMULATOR AND JACKPOT

There is no refund on scratching. If a horse is scratched in any leg, it is automatically replaced with the favourite (Determined by Africabet)

WIN BET: Your selected horse must win the race

PLACE BET: Your selected horse must place in the race. The odds will be determined by Africabet, before or after the event. In a race where there are 14 or more runners , the first four places will pay a dividend and where there are seven to thirteen runners, only three places will pay a dividend. Where there are four to six runners only two places will pay a dividend and where there are three or less runners no places will apply.

SWINGER BET: Selected TWO horses to run in the first three places in the race. Your selected can finish in any order. In the event of 4 or 5 runners there will be only one swinger dividend.

EXACTA: Select the horses placed 1st and 2nd in correct order of finish.

TRIFECTA: Select three horses to finish 1st, 2nd and 3rd in correct order.

QUARTERT: Select your horse to finish 1st, 2nd, 3rd and 4th places in their correct order.

JACKPOT: Select a horse to win each of the Four races (legs) that make up the jackpot. Win determined by Africabet. Couplings do not apply.

PICK 6: Select a horse to win each on the SIX races (Legs) that make up the pick six. Win determined by Africabet. Couplings do not apply.

PLACE ACCUMULATOR (P.A): Select a horse to place in each of the SEVEN races (Legs) that make up the P.A. Placings will be determined by Africabet. Dividends will be paid in respect of horses placed 1st, 2nd, and 3rd as follows: 8 or more runners, 3 places; 5-7 runners, 2 places; 4 runners, 1 place.
